- 2 All vehicles to be parked outside the grounds between 9am and 5pm.
- 3 Only items included in your application and approved by the committee to be sold at the event. We reserve the right to remove items that do not comply.
- 4 You are required to bring your own power leads. All power leads must have current test tags. This is your responsibility. Cords will be inspected.
- 5 Applications will not be accepted until full payment is received.
- 6 Food vendors and rides must provide a Certificate of Currency of their Public Liability Insurance (min \$10,000,000)
- 7 Attendance at SteamFest is at your own risk, and SteamFest will not be liable for any damage to property whilst on site.
- 8 Satisfactory Risk Assessment to be lodged.
- 9 It is expected that stallholders will attend the event all three days until closing time.
- 10 The committee can request that stallholders comply with all requests made for health & safety reasons & that if the stallholder does not comply, they can be asked at any stage to leave the festival.
